Encino Energy's top priority with our stakeholders is transparency, communication and fairness. We deeply value our relationships with all our business partners, especially our land and mineral owners.

Given our ongoing commitment to greater transparency with our royalty owners, and our focus on earning trust each day, the information found on our Form 1099s includes information including gross royalty, taxes and deductions associated with landowner accounts. This heightened level of information aligns with the Internal Revenue Service's 2019 Instructions for Form 1099- Miscellaneous Income, and believe it will aid many of our landowners in complying with 2019 Instruction for Schedule E.

Last year was evolutionary for Encino, and we appreciate your continued patience and understanding as we worked through the administrative aspects of the acquisition process together. We do understand that the additional level of detail found in the Form 1099s may have caused confusion as compared to previously issued forms.

While Encino does not provide tax advice, below is an example of an actual Encino landowner's check and the associated Form 1099. Landowner "Tom Smith" received \$3,811.67 via direct deposit. The gross royalty reported on the Form 1099, as defined by the 2019 Instructions for Form 1099-Miscellaneous Income, shows \$9,521.22. "Prod/taxes" show \$66.15 and "Other Deds" (aka other deductions) show \$5,643.40.
